### A META-ANALYSIS OF IMPERATIVE FOR RESEARCH ON INTERDISCIPLINARY HEALTH CARE TEAMS

### Introduction

Limitations of traditional medical systems to deal with complex health issues during the last two decades have prompted the use of interdisciplinary health care teams. Currently, much of the interdisciplinary health care team literature is descriptive in nature making it difficult to focus research imperatives. The purposes of this report include development of a systems research model to analyze the impact of interdisciplinary teams in health care and to define topics and questions for research on interdisciplinary teams by a meta-analysis of published reports.

Clearly there are both skeptics and advocates of the value of interdisciplinary teams. Skeptics note that the current literature has few and often inconclusive reports showing rigorous, scientific evaluations of the impact of health care teams (Heinemann and Tsukuda, 1986, p. 134). Skeptics cite problems concerning leadership, control, authority, coordination, and efficiency. Advocates of interdisciplinary teams appear equally committed to their assumptions and beliefs in positive outcomes of the team approach. As one advocate, Doctor T. Franklin Williams, director of the National Institutes on Aging, states it:

"...It is clearly impossible for any one profession to address adequately the full range of problems older patients often present, usually at times of crisis - medical or social. The rapid appearance of multidisciplinary geriatric assessment and consultative clinics and services in many settings, staffed with physicians, nurses, and social workers, all of whom are directly involved with the work-up and planning for the care of the patient and the family, together with the use of other consultants, all speak to the growing recognition of a team approach. To be a complete geriatrician means to be a team geriatrician."

### A Systems Research Model

The complexities of interdisciplinary team care often confound systematic research designs and traditional methods. Heinemann and Tsukuda identified four broad areas of complexity that challenge and pose difficulties for researchers: "the geriatric population, itself; theoretical assumptions regarding our expectations of teams; definition of concepts and measurements of variables; and research design." They suggest future research needs to focus on inputs, processes and outcomes. These three components comprise a traditional systems model as shown in Figure 1. In addition, these three components need to be considered in the environment, or context, in which the interdisciplinary team functions.

A review of the literature identified numerous contexts in which inter-

disciplinary teams are prepared to practice and deliver care. Universities and their clinical affiliates as well as community settings are actively involved in preparation of practitioners to function in interdisciplinary teams. The contexts in which interdisciplinary teams function include but are not limited to geriatric settings in long-term care, psychiatric units, pediatric care units, rehabilitation institutes, diabetic care centers, chemical dependency programs, home-care, nursing homes, hospice centers, adult day-care and respite care settings.

Figure 2 graphically illustrates and defines the three systems components of input, process, and output. Input is defined as preparation to serve in an interdisciplinary team in terms of education and training. Process is defined as the interaction and activities of the team providing care in practice. Output is defined as the quality outcome of the teams efforts as measured in broad terms of team effectiveness and efficiency.

### Materials and Methods

To identify imperatives for research on interdisciplinary health care teams, the meta-analysis technique was used. Meta-analysis, a research methodology for analyzing and integrating information from a collection of existing reports, was applied to the Interdisciplinary Health Care Team Symposia Proceedings.

The meta-analysis was conducted in two phases. In the first phase the reports, totalling 255 papers, were analyzed for inclusion under one of three categories as illustrated in the system research model: (1) input - education and preparation of the interdisciplinary team; (2) process - interdisciplinary teams in practice; and (3) output - measures of team effectiveness and efficiency. It should be noted that overlap between each of these three general headings is inevitable, hence a report could reasonably be categorized under more than one area.

The second phase of the study consisted of reviewing each article to identify specific recommendations for further research. This was accomplished by seeking answers to four questions: (1) which professions participated in the interdisciplinary team; (2) what variables were studied; (3) what were the general outcomes; and (4) what suggestions did the authors offer for additional research.

### Results and Discussion

Each of the reports, categorized under the headings input, process, or output are listed in Tables 1, 2, and 3 respectively. Although space limitations preclude listing all the findings of the reports analyzed, Table 4 is an example of the responses to the four questions posed during the meta-analysis. As can be seen, individual reports often overlap more than one component of the systems research model. A variety of health professions were involved in the interdisciplinary teams in the studies. The variables studied were appropriate to the component of the model under investigation. All reports had some positive general outcomes, although not all clearly stated suggestions for additional research.

While studies of interdisciplinary teams have been conducted in a variety of environments or contexts, additional research should attempt to identify variables inherent in different settings that either promote or hinder the effectiveness or efficiency of interdisciplinary teams. Variables may include proximity to traditional care models and length of time the team has functioned, for example. These variables should be included as demographic factors when reporting studies on interdisciplinary teams.

The majority of citations reviewed under the input category described educational experiences, either at career-entry or through continuing education, and curricular content to prepare professionals for interdisciplinary team practice. Additional research needs to focus on faculty preparation to provide these educational experiences, replicated studies of student interaction during the learning experiences, cognitive gain regarding the process of interprofessional collaboration, shifts in attitudes as direct result of the interdisciplinary team educational experience, and development of uniform assessment tools to measure the learning experience. Research imperatives also include comparisons of the instructional effectiveness of different approaches, and the impact of interdisciplinary team training on practice. An example of the latter would be an assessment of the impact of enhanced training in team problem solving skills that could use the quality of patient plan assessments as the study variable to measure team interaction.

Reports under the process category, although largely descriptive also, prompt imperatives for research within teams, between teams, and teams working in different environments. Replication of existing studies using such variables length of hospital stay, use of medications, comprehensiveness of care, identification of new problems and diagnoses among patients, and patient discharge planning should be done. Additional research should include antecedent variables that predict team effectiveness, and characteristics of effective teams in practice using such variables as leadership, autonomy, and interaction. In addition, studies should be conducted within specific contexts to analyze the theoretical issues at the core of developing an interdisciplinary team.

Finally, reports categorized as outputs of interdisciplinary teams offer models for replication and study of variables assessing team effectiveness and efficiency. A number of reports cite assessment of patient satisfaction between team and non-team approaches. These deserve replication, or at least a consideration of this assessment in future studies. Similar to those variables noted under the process category, length of stay and patient discharge planning merit additional study. Future studies should also investigate readmission, functional status of patients served by team, and the quality of patient care plans developed by interdisciplinary teams.

### Summary

The purpose of this report was to explore the need for systematic research on the impact of interdisciplinary teams and to suggest additional research needed. A systems research model was described followed by a meta-analysis of select reports to identify research imperatives. These results are of value to educators, practitioners and researchers for focusing a program of inquiry on the contribution of interdisciplinary teams in health care delivery.

# The Systems Model

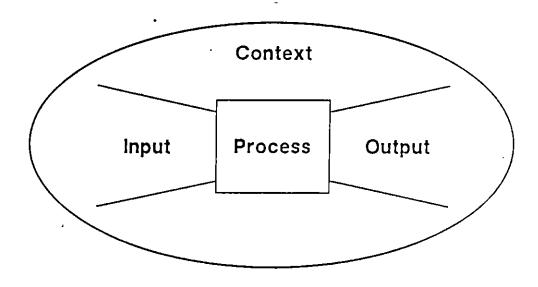

# A Systems Research Model

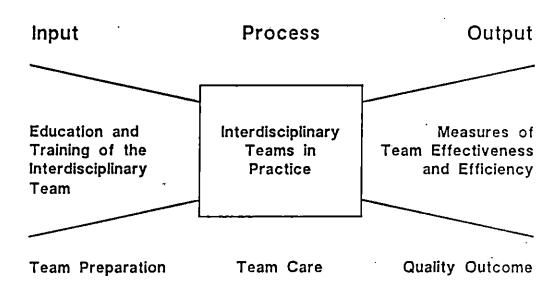
